**THE ROCKWELL MUSEUM RIGHTS AND REPRODUCTION AGREEMENT
TERMS AND CONDITIONS**

1. Written permission must be obtained from the Registrar of The Rockwell Museum ("Rockwell") prior to any reproduction or publication of the Rockwell objects or building.
2. All reproductions must be made from photographic materials or digital images supplied by the Rockwell. Reproduction from printed or other non-photographic material or digital images is strictly prohibited.
3. The reproduction must be accompanied by the ownership credit. The Rockwell prefers placement of this information in immediate proximity to the reproduction but will accept, upon application, placement elsewhere, such as in the index or list of illustrations. In case of television, films or other video broadcast, full credit must be included in the film/broadcast credits and/or the accompanying manual.
4. Permission is granted for only **ONE** usage in **ONE** publication, **ONE** edition, and **ONE** language. Any further reproduction shall require written permission of the Rockwell as well as any appropriate additional fees. Such use excludes any reproduction for purposes of advertising or promotion.
5. The Publisher/Video Producer or Distributor/Website Administrator must send, upon publication or initial broadcast/airing and without charge, one copy of the publication/video or access to the website in which the reproduction appears to the Registrar of The Rockwell Museum.
6. In the reproduction process, the reproduction may not be cropped, bled off the page, overprinted, printed on color stock or altered in any way without prior written approval from the Rockwell. If a detail is used, it must be identified as such.
7. The Rockwell can grant permission to reproduce only to the extent of its ownership of rights relating to the request. Certain photographs/images owned by the Rockwell may be protected by copyright, publication rights, or related interest not owned by the Rockwell. The responsibility for ascertaining whether such rights exist and for obtaining all other necessary permissions remains with the applicant.
8. Any unauthorized use of photographic materials or digital images supplied by the Rockwell by any person or entity, for any reason, will render applicant responsible and liable to the Rockwell for the appropriate compensation and other costs, regardless of whether applicant has profited or is responsible for such unauthorized use.
9. The Rockwell reserves the right, as its sole discretion, to refuse permission for further applications from a publisher or other applicant, if in its opinion, acceptable standards of reproduction have not been obtained or if adherence to the terms of previous contracts has not been upheld.
10. The Rockwell gives no exclusive rights to any publisher, author, or photographer and assumes no responsibility for duplication of subjects by others or any responsibility for claims by third parties.
11. Permission to reproduce objects in the collection of The Rockwell Museum is conditioned upon acceptance of the above regulations. Any breach of these terms and conditions will automatically result, at sole discretion of the Rockwell, in revocation of permission to produce.

The applicant agrees that permission to reproduce shall be subject to the conditions listed above and further agrees to pay promptly any charges as invoiced.
